6. Investor preferences should inform the portfolio. Not the other way around.

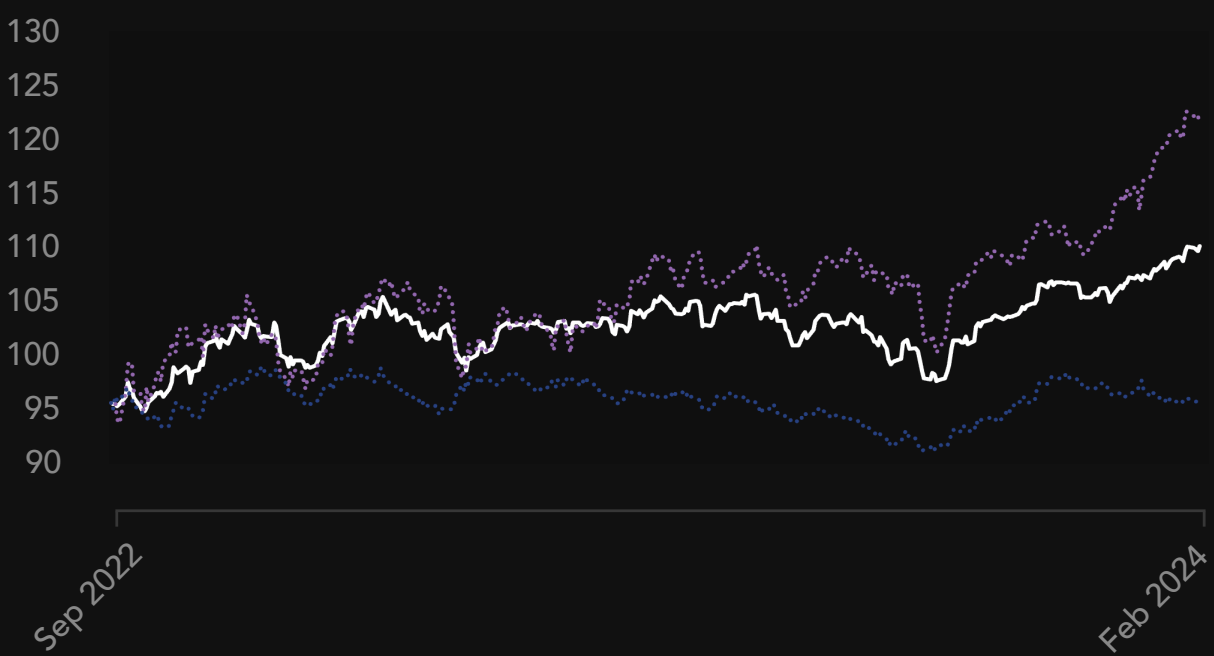
Performance
